Thank you. Our first speaker this evening is Jim Thornton, a resident from Harford County.

Good evening commission members. My name is Jim Thornton, and on behalf of the Harford

County caucus of African American leaders.

I would like to thank you for the opportunity to speak tonight, the caucus mission is to advocate for fairness, equity and inclusion of African Americans in Harford County.

We began by commending Governor Hogan for establishing the commission as an essential part of the 2021 state redistricting process, this multi partisan approach will help to promote fair and effective representation, and the Maryland General Assembly

House of Representatives. Before I share my specific comments I would like to express our appreciation to each of you for your time commitment to this critically important process, which takes place every 10 years, my brief comments speak to equity and

fairness. Harford County was created by the state legislature in 1773. It was the sixth county created in Maryland, which at the time had roughly a population of 3000 people.

Today it has an estimated population of approximately 256,000.

It is a county becoming more diverse, with over 20% of them being people of color.

We know that there's also a representation and terms of the hard to count which was part of the 2020 census, which are communities that rank high on the Center for Disease Control, social vulnerability index.

These maps show that all too often undercounted communities are also underserved. While all voices must be heard. So it must be amplified. For the sake of equity as new maps are drawn, we must all work together to engage these communities.

Next we recommend flexibility as you tackle the question of single versus multi member districts, and as I recommend to merge district 30 for A and B, and to a single district with three at large members.

This structure will increase the possibility of a person of color being elected to the General

Assembly Harford County has never had a personal color to serve in the General Assembly.

Further we recommend consideration be given to eliminate representation made up of two counties. This type of configuration is unfortunately at least one of the counties receiving less than full attention of the elected officials in each of the respective counties.

The current configuration has Harford County sharing a district with Baltimore County to the west and so counted to the north, this alignment inherently creates losers and winners.

groups across Maryland with over 50,000 members, and I thank you all for taking on this major task. We understand that changing many of the gerrymandered districts is important.

side were divided with Calvert and St Mary's on the other side were divided with Prince George's County. We're looking to really have our county as a whole.

to enact some uniform standards to guide the process. As I think many of us would agree redistricting reform in Maryland is desperately needed and has been overdue for decades.

Maryland has been the leader in so many areas but redistricting is not one it's one where we are woefully behind all of our other states with regards to reforms.

I'm going to focus on my oral comments on house legislative standards and will submit more comments to you all, including congressional redistricting and writing.

First of all, I believe that each legislative delegate district shall be divided uniformly into three single member districts, respect should be made for natural boundaries and boundaries of political subdivisions.

As you all know, in Maryland.

County and, including Baltimore City, are meaningful to the boundary lines of the counties in the city, and have historically been significant political units. I think there should be a high priority to minimize the splits between districts between the county and the city.

Why do I support single member house districts, after the last redistricting in 2010, my compact community of sites of Eldersberg was unfairly split right down the middle and half was put in a large three member district district five that extended

55 miles to the north to the Pennsylvania line and the southern half of the district was attached to a two member legislative district that consisted mostly of our county residents, nothing against our county.

All of the elected officials resided in our county. We also had the same up to the west of us with a split over into Frederick County. So we have an 11 member delegation now, but only for of the people that represent Carroll County actually live in Carroll

County, needless county splits and districts makes it very hard to achieve strong ties between a county and is delegation, an effective representation of county business and Annapolis, for example, each county has meetings with their local boards of education

our teachers union, our county officials, our community colleges, our hospital, our Chamber of Commerce, veterans group Farm Bureau disability advocates and so on.

Those who have to represent two counties have doubled the task, they have to attend to both, both set counties and sets of constituencies. And given that we're a citizen legislature I most legislators hold outside employment, attending to two counties

It is a huge challenge and one gets left behind.

Nationwide the use of multi member districts has declined dramatically over the last several decades, and this is in part because in some jurisdictions they had been found to be

discriminatory Maryland is only one of two states in the United States that

will have multi member districts of different sizes in the whole country.

Some will have one, some have one, some have two and some have three member districts, this is every other state has moved away from it except for New Hampshire and Maryland single member districts also allow for more minorities to be in the majority and deserve to be.

We know that the complications of congressional redistricting are it has to be down to the person so there are going to be some squiggly lines and crossings, but we have to vitally important to keep communities together Carroll County is currently split

between two congressional districts. For the first this last 10 years has been the first time that really had happened in any recent history. The first district runs from tiny town in our western side of Carroll County, all the way to Ocean City and is

primarily an Eastern Shore district in northeastern Maryland, the eighth district is worse, over half of Carroll County is connected to a district where 70% of the population is in the inner DC suburbs, the district actually looks like the nation of Thailand

If you look at it, standing alone, many of our congressional districts are absurdly shaped, even for a state like Maryland that is an unusual shape.

We are, it is my firm belief and many of my constituents and express this to me directly, we should be restored to a congressional district that unites Carroll County, and ideally unites us with our fellow Western Maryland counties as was the case, historically

for many decades, on state legislative redistricting. I'm going to start with the senate focus.

Carroll County appears and we don't have all the numbers but it appears that we're going to have the right population for one full state senate district with enough left over for one more single member delegate district that can be attached to another

I'm right now go there with the roughly the same proportion population there's parts of three senate districts running into Carol, my district takes up most of the county's land mass which I think is good, but the got the Martin O'Malley gerrymander of

2012 put small pieces of Carroll County as delegate Krebs alluded to in one part of the county it's into a separate senate district and another little piece of the county in math areas and another separate district nonsensical and she illustrated wise

We have 11 members of the delegation; only four of us actually live in the county.

Finally with House of Delegates our submit boards by written comments but delegate Krebs made great points, there should be single member delegate districts in Maryland, it makes it makes so much more sense for people to know who their delegate is and
