The first thing is that I think that we should agree on what our objectives are. And, to my mind, there are four. They are to equalize the populations of all CDs within a state to keep neighbors neighbors together defining neighbors as people living in

the same zip code tabulation area to dry compact shape, and to avoid all other considerations I think that's important. We have many considerations that have been considered in redistricting in the past.

Some of them have been ruled illegal. Some of them have Supreme Court has allowed to continue to exist, like political affiliation and political gerrymandering on, but others, such as race and ethnicity have been determined determinative and not allowing

certain districts that discriminate on that basis, but I think that all of the considerations. Taken together, we'd be better off without any of them, because we would end up with.

If we just use population compact as needed keeping neighbors together. If we follow those three things we will be much better off.

Secondly, I think that we should agree that the worst back practices at present are that politicians pick their constituents, rather than the other way around.

And the best way to get around that is to have a system that is based on mathematics and rules for drawing districts, and we have no human decisions. If you really come up and there are schemes that can be done.

I have one, I'm sure other people can come up with other schemes that would work. But the whole idea is to eliminate human decision making, so that as I like to say any high school civics class could follow these rules and create district boundaries and

they would be the same in every state, and every district map drawn would be the same. They should be transparent and replicable.

Then we get into the actual details of how this is done. I use a series of reference lines and scan lines, and basically scan across the state, using zip code tabulation areas to form districts.

I believe that the congressman who represent six and eight right now, even though some people do not think they represent them have worked on things such as broadband availability and fighting mental illness and fighting the drug problem which is a problem

have received a map, a spreadsheet and written testimony from me. But I want you to take a look at that I took all the legislative districts and map them color coded them by the percent of median from ideal from the ideal population size and Maryland

All of the districts on the eastern shore and in southern Marana Central Maryland more conservative leading suburbs and x urban communities of the state are all grossly under represented the average delegate in Baltimore City represents almost 4000 people,

less than a district on the eastern shore, and I'd like to know why is that fair.
