the Baltimore County democratic state Central Committee. And over the past few weeks I've had the opportunity to not only hear from voters and constituents in Baltimore County regarding their interests pertaining to redistricting that I hope to share

with you tonight. But before I do that I want to do what I like to always do and lead with the data. Maryland is the seventh most diverse state in the nation, gender and racial representation in Maryland State House continues to outpace other states.

According to the new national census of state legislature Maryland's increase in racial diversity over the past five years was more significant than our surrounding states.

According to data, published in, on October 12 2020 by the National Conference of state legislature, and I quote Maryland legislature overly has become significantly more female and more racially and ethnically diverse with a number of black legislators

and Marilyn Brett rising to 29% lawmakers of Caucasian descent decrease the 61% legislators of Asian descent dropped from four to 3% and there was no change in the Hispanic representation is for state legislature also want to note the Maryland, also the

richest state in the United States of America. And regarding voter registration data, the likelihood of a Marylanders or Baltimore County residents particularly, but Maryland in general registering democrat versus republican is two to one.

So with these facts in mind the Commission has a difficult job to balance all of the desires of this diverse constituency, but I want to call out these two things and I hope you keep it in mind to maintain proportional representation to ensure partisan

I know personally because my dad owned a home on Hopewell Avenue. So on the left side, if you lived on the right side of hope. Well, that was part of District, six, and then if you lived on that left side.

I am here to ask you to support transparent map drawing that keeps communities of interest together.

There are a total of four congressional districts in Baltimore County, 123 and seven.

My Congressman, Mr quiet as implemented is responsible for the seventh Congressional District, which includes parts of Baltimore and Howard County and greater than half of Baltimore City.

Howard and Baltimore counties are the second and third largest counties in Maryland, where does that leave the congressman's priorities in the seventh congressional district.

Does he know the issues that impact my home, or my community where my grandkids go to school.

Baltimore City has a poverty rate of 23%, Baltimore County has a poverty rate of 8.9% and Howard County has a poverty rate of 5%, very different communities with very different needs.

By the way, community means that feeling of fellowship with others, as a result of sharing common attitudes interests and goals.

the Maryland League of Women Voters does support both single and multi member districts when appropriate, but it does get frustrating not knowing who to call when trees in your backyard that are on county property, start to die, believe also supports

The Arab and Pikeville is an example of how vital and important one such community of interest is. It is vital that every 10 years these folks don't have to worry about who is going to represent them and how their lines may or may not change.

City as well as you know, has a fewer population than one congressional district yet they have three Congress, Congressman that represent them. I'm just so thrilled with the charge you've been given and the effort to put forth a nonpartisan redistricting

map for congressional maps, but I also am anxious and thankful that you'll be looking at our state house maps. You've heard some things about single 212 and three member districts.

So I think it's appropriate that those subdivisions. Be as contiguous or distracted as continuously as possible. I've seen pieces of Baltimore County put into Baltimore City in Harford County and Howard County and and Rondo County, and it dilutes

the voting power the voting strength to the residents of Baltimore County when we get to Annapolis.

The second thing is, is district splitting like I just mentioned, all these districts that gets shoved across different lines. I think that if you're going to split it any districts between two subdivisions.

district size was a problem when Donald Schaefer withdrew the lines and Rowan County districts were over 100,000 Baltimore City districts are under, under 100,000 it diluted the strength, the man or the county.

My address is Owings Mills, but I and other citizens are cut off from the rest of the community by one block on the congressional map.
