Absolutely no objection. I'm just going to launch right in and the earlier parts of the program are going to be a chance to be briefed by the staff so I won't have much to say as Chair later on we'll have a chance to discuss, where we go next, but I'm just

going to turn the microphone right back to Kristin for the agenda. The first item is census data release which of course is the most timely of all of the items so Kristin take it away.

Yeah, so, so really excited for tonight's meeting we have a lot to update you guys on. So it's going to be a pretty packed agenda. The first and foremost item though the thing that's kind of the most exciting for us at the Department of Planning is that

the census data is being released tomorrow. We've spent the last couple of weeks prepping for that, so that we can turn that data out to everyone as quickly as possible so that not only the members of the Commission have that data in your hands as quickly

as possible but also that the members of the public can access it through the Maryland State Data Center website.

All of those links will be made available tomorrow. So tomorrow there is a press conference between one and 2pm by the US Census Bureau. We are told that the data will start to be released at 1pm tomorrow.

We don't know when Maryland's got Maryland's data is going to arrive in our you know into our inbox is, but we should be getting that sometime between one into our data team who some of you have some of you have met are outstanding and have been prepping

for a really long time, as to every aspect of how tomorrow is going to work and how that information is going to be conveyed to the public, the format that it comes in.

And I just want to remind everybody about this in case you're talking with other individuals about it, the format that it sent in by the Census Bureau is something called a legacy format.

The reason that Maryland is able to use this format and not have to wait until September 30th is because it is the format that we've used in the past we, we have the tools we need to open that data and review that data.

And so what we'll be able to do is take that data and translate it into tables for members of the public that are easily readable downloadable Excel spreadsheets.

We will also be endeavoring to put that on a map so it's kind of easy for you to see at a glance.

We will try to do that, the mapping part, make it may be easier to do the tables, but once the tables are done will try to put it in a map also, So it all depends.

Actually the Census Bureau may be releasing things based on smallest jurisdictions first. So it just depends on which way they decide to release the data so we won't be the first to be getting data but once we get the data, it will be compiled in a way

that will be useful to you, and useful to the public, and then we will try to create the tables. And then after creating tables, we will try to create the maps, you will see a map that has merit increases and decreases, and you'll have a map that shows

percentage increases and decreases. So, then you'll have kind of bandwidths kind of almost like a heat map for Maryland about within this range of percentages, the populations went up and the populations went down.

drills down significantly to sentences block to municipalities to load to local jurisdictions, by, by race by gender individuals over the 18 and all those tables are going to be available to you.

And I will send you guys a link to that website tomorrow as well so you can go right to it. But what we have to remember for redistricting purposes and what the public has to remember for redistricting purposes, is that we can't use that data to start

drawing lines, until the population of Maryland's prisoners have been reallocated to their last known home address. So that means that the numbers in say for, say for example the numbers in Toronto county will be potentially, then they will be after that

prisoner reallocation, because there are correctional facilities in the Jessup, part of Maryland, same would apply for Western Maryland eastern shore and the like.

So just keep that in mind, that's the reason why we can't use the data, because all of a sudden census tracts that you might be trying, trying to draw lines with all of a sudden those census tracts don't have as many people in them are all of a sudden

have more people in them. That's the whole, the whole rationale is prisoner reallocation, and it's the law and Maryland that those that has to occur before we can use that data to draw lines.

The same applies for any Marylanders, who are going to be submitting maps, we are letting them know, here is the data there is a disclaimer on the website.

Here's the data for you, but we cannot accept maps into the prisoner reallocation data is finalized and utilized for any map submissions. That's the whole, the whole purpose of that, again, all of that information will be posted by close of business

So male female age, race, all those attributes of a person will get dropped in it's not simply a matter of a one slash goes into one block all the attributes of the census attributes of that person get dropped into that census block also so we're going

Does anyone have any questions for us with regard to the census, the census data released tomorrow?

to make sure we confirm every address that can be confirmed. And so, that process, we were able to have the good addresses, we were able to have almost 96% success rate in the reallocation process geographically so of the good addresses.

Now we don't have a good address from every person, upon intake, maybe several years ago, that didn't match up to an address that still exists today but everything that we have that we can confirm as a good address, and sometimes the North, or the south

part of a street, we had to figure out there's not enough. No three hundred on North Main Street so it had to be 300 South Main Street, and if they gave a partial address of falls way falls road.

We've figured that out. We've done all that pre work to confirm those addresses and set them on XY coordinates, so they've all been done, and your question was about the number.

And I would say just a little bit above or below 15 was a number I was been working with in my head, 15,000, and in your models of this.

And I'm sorry to invite speculation but would it be fair to say that no single county is likely to rise or fall by more than maybe 3000 or.

Is that too speculative.

We had originally scheduled to hold some public meetings for round two. On August 25, August, 31, September 1, and September 2 those four meetings cannot be public meetings for round two, because we won't have the prisoner reallocation data back yet.

and the whole purpose of round two is absolutely not to be a regurgitation of round one. That is not meant for members of the public to give us their thoughts and concerns on their feelings about the process of redistricting.

The purpose of round two is for members of the public to be able to provide you map submissions input on other maps submissions input on the data and how that may impact your drawing of the lines.

It is a data driven round that focuses on district line drawing.

And so it can be statewide.

And you can have statewide meetings because they're all virtual anyway.

And so I wanted to just kind of put that out there for discussion among you, because what you might want to do is condense the number of meetings that you originally were going to have in round two, and have fewer perhaps a little bit longer than they

lead that discussion about round two. Before we talk about round three. But while you're talking about round two. I would then clarify for all of you that you start a working session on the 23rd of September, and that's just a date that we have there

you to consider with regard to those numbers. And so that's the purpose of round two is really kind of that data driven, members of the public who want to provide you information that you can utilize when you draw your maps or input for you to utilize

depending on what state you're in. And that is a lot, allowing ourselves to move up the curve, and allowing ourselves to discuss and reach some sort of consensus on what is meant by the high Sundin language in the governor's order.

Governor has ordered list a bunch of criteria, like compactness like respect for county boundaries.

lists a bunch of criteria, like compactness like respect for county boundaries. It rules out a bunch of others, such as use of political data and then is totally silent on yet other ones and let me raise one or two that the governor is our executive order

is silent on it doesn't say for example, when looking at the state legislatures mouth, whether we should treat the existing mouth as deserving, a little bit of difference as a starting point that's often something that people do instead, they try to carry

forward, historically, where a district has been.

We should probably have a discussion among the nine of us of what we think of that idea, whether we want to start on a completely blank slate, whether we want to give a tiny bit of respect, or maybe a lot of respect, and that depends on, you know,

each of our nine views so that each of these concepts which we've heard about a lot.

I promise turns out to be more complicated compactness sounds so good that every single step practically except Maryland for congressional districts asks for compactness, but there are several different ways of defining it, and they have different implications.

And we want to learn about that so that we aren't unprepared if someone criticizes us for having a person district that's good on one kind of compactness but flunks a different definition of it we need to learn about the tradeoffs, the more compact

you try to make them out, the more you may be invited to split counties, which is also not good on something as simple as equal population, again, for the House of Representatives it's out of our hands because it has to be exact.

When it comes to the state legislative district. Again the governor's order, probably gives us some discretion to we have it at plus or minus 2% derivative plus or minus 1%, there are advantages and disadvantages of doing it.

Again, we need to bring these issues up devote some time to learn each other's views. Allow the best arguments on both sides to be Eric from the nine of us. And one reason this is important and I'm taking this directly from the seminar that did on national

Conference of state legislatures put on is that problem that Commission's get into changing their mind halfway through, they think that they don't care about some Carter and then they can help with his mouth, and they say oh wait a minute we do care about

it so they begin drawing the district's differently, and it's at that point that the public yells and maybe even someone thinks they should hire a lawyer, because different parts of the state are not being treated under the same principles.

You want to try to think of these issues ahead of time, rather than afterwards so that different portions of the state are getting the same principles apply to them, and also so that we don't stop halfway through some interesting geographical question,

and have to go back and spend an hour, sorting out what we think, what is it possible sort of spend that hour before September 30 or whatever the data is.

So all of those reasons are reasons why we need to spend some time on getting into the toolbox of criteria is one more thing that I think it would behoove us to spend some time on because it would prepare us for dealing with the maps that are going to
